Surface Preparation	All subfloor surfaces shall be dry, smooth, sound and clean, free of wax, grease, oil, old adhesive, paint, curing compounds, laitance, bond breakers and all other contaminants that inhibit adequate adhesion to the sub-floor. The sub-floor must also be free from hydrostatic pressure or capillary action. The adhesive should not be used in xcessive cold or hot conditions i.e. below 8°c or above 28°c. Uneven or damaged floors should be repaired with a cementitious levelling compound. All subfloors should be tested for moisture content prior to surface priming or application of this adhesive. The moisture content of the sub-floor should not exceed 5.5% and or the relative humidity should not exceed 70%. Do not use this adhesive if the moisture content /relative humidity levels are above the acceptable standards. All subfloors should in accordance with current Australian standard installation practices

Application Information	Stir the adhesive thoroughly before use. For synthetic grass applications, apply the adhesive with a V5 trowel and for needle punched carpet installations apply the adhesive with a V3 trowel. Install the floor-covering into adhesive whilst the adhesive is still wet. As work proceeds, remove any excess adhesive off pile surface or surrounds. As the adhesive is solvent based, when laying outside make sure that the weather conditions are conducive to laying, as the adhesive takes 4 hours to cure, before being water resistant, and 48 hours before being water proof. It is advisable to use plastic or polythene sheeting to cover work areas if weather becomes unsettled. Roll the floor-covering per the manufacturer's instructions
Limitations	This product is flammable. Use only in well ventilated areas. Keep away from heat, sparks and naked flames. Avoid contact with skin and eyes. Avoid breathing vapours, if swallowed do not induce vomiting, give plenty of water or milk and contact a doctor.
Storage	Do not allow adhesive to freeze, unaffected by freezing when dry.
Shelf life	This adhesive has a shelf life of 12 months from date of manufacture, providing the pail is unopened and under cover at 20°C.
Clean-up	Clean up surfaces and equipment whilst adhesive is still wet using FULLATAK SC Cleaner.
